# **Website Privacy Notice**

The New Collaborative Learning Trust vision is to create a culture of protecting privacy and personal data. Personal data is information which 'relates to and identifies a living individual'. Personal data should be adequate, relevant and limited to what is necessary.

## **DATA CONTROLLER AND COLLECTION**

The organisation responsible for looking after your personal data (Data Controller) is the New Collaborative Learning Trust. Content for the websites for the Trust and for individual colleges within the Trust is managed by NCLT.

#### **COLLECTING INFORMATION**

Most information is collected automatically. Where personal information is not collected automatically this will be made clear at the point of collection.

## WHY DO WE COLLECT AND USE INFORMATION?

Automatic information is processed to estimate how much use of the server is made by different categories of users and, in the event of a breach of security, may be used to aid detection. Users are able to provide their information through electronic forms embedded in our website to be kept informed about job vacancies that are available and for news and updates.

## **CATEGORIES OF INFORMATION**

As with most other web servers, when you access these web pages certain information you provide will automatically be recorded by the College. This will include:

- Your IP address
- Browser type
- Information relating to the page you last visited.

Where you are required under this website to provide personal data, the uses of this data will be indicated at the point of collection - for example, when registering your interest for upcoming vacancies.

## STORING DATA (HOW LONG IS DATA HELD FOR)

We will store data for no longer than necessary, in accordance with data protection legislation and best practice. Retention of data includes the following:

Automatic information

30 Days

Non-automatic information

1 year (reviewed each year)

## **COOKIES**

Cookies are small text files that are placed on your device by websites that you visit. Our website uses cookies for two purposes:

- Essential: These are essential to the website and ensure it works. They are first party cookies set by our web server;
- Performance: These collect anonymous information about the use of our website and help us making continued improvements to the site

#### We do not use cookies to collect personal information about you.
